The Chairman of the Council noted that despite the multitude of issues to be discussed, the proceedings concerned three schools. He appealed to experts, board members and stakeholders to come together to present issues related to each school and then vote. The said motion was shared by the council members.

The chairman of the council, Davit Malazonia, asked the representatives of the institutions if they had any complaints against the members of the council. The representatives of the institution confirmed that they had no objections to the members of the council. The chairman of the council, Davit Malazonia, appealed to the members of the council to confirm that they were familiar with the conclusions of the authorization expert group and the argumentative position presented by the institution in relation to the draft conclusions. Council members confirmed that they were familiar with the case materials. The Chairman of the Board, David Malazonia, asked the stakeholder representative if he was familiar with the findings of the Authorization Expert Group. A representative confirmed that he was familiar with the findings. Accordingly, the Chairman of the Council requested the Secretary of the Council

The chairman of the expert group, Tsiala Gagnidze, made a presentation about the results of the assessments carried out at the Georgian-American high school.

to attach the conclusions of the expert group to the minutes as an integral part thereof.

Tsiala Gagnidze noted that the school in Chkondideli st. The space in N18 was authorized on September 28, 2022. According to the decision of the council, the maximum number of places for students in the building located in N18 of Chkondideli was determined with 1250 units. After that, the school acquired St. In Tbilisi, Chavchavadze N44(b) non-agricultural purpose 542.00 sq.m. Located on a plot of land of 795.4 sq.m. The educational purpose building of the area and was subjected to monitoring within the scope of the administrative proceedings of the change of area/address, so that the number of students did not increase.

On July 19, 2023, the school additionally acquired St. Tbilisi, 44 Chavchavadze St., 664.51 sq.m. Farti building - a building that was located at 44(b) Chavchavadze Street, in the adjacent territory of Georgian-American High School LLC. The school wanted to increase the maximum number of student places by 250 students and set the total number to 1500 students. Tsiala Gagnidze noted that the group

of experts evaluated the requirements defined by the third standard of authorization and it was evaluated in accordance with the requirements of the standard. He also presented the visual material and

noted that during the visit the finishing works were in progress, which was completed, which was confirmed by the visual material presented during the argumentative position of the school. The chairman of the board noted that the findings were so specific

that it seemed that the school would be able to serve 1,500 students. He asked the council members if they had any questions. Council members had no questions.

The representative of the school applied to the council with a petition, the decisions made about the change of the place/area of implementation of general education programs and the increase of the maximum number of places for students, should come into force from September 18, so that the school could implement the educational process on the mentioned area. The council unanimously supported the said motion.

The Chairman of the Council put to the vote the issue of changing the place/area of implementation of the general education program of the elementary level of the Georgian-American High School LLC.

The chairman of the council, Davit Malazonia, asked the representatives of the institutions if they had any complaints against the members of the council. The representatives of the institution confirmed that they had no objections to the members of

the council. The chairman of the council, Davit Malazonia, appealed to the members of the council to confirm that they were familiar with the conclusions of the authorization expert group and the argumentative position presented by the institution in relation to the draft conclusions. Council members confirmed that they were familiar with the case materials. The Chairman of the Board, David Malazonia, asked the stakeholder representative if he was familiar with the findings of the Authorization Expert Group. A representative confirmed that he was familiar with the findings. Accordingly, the Chairman of the Council requested the Secretary of the Council to attach the conclusions of the expert group to the minutes as an integral part thereof.

The Chairman of the Council directed the Chairman of the Expert Group to present a brief overview of the issues to be discussed within the framework of all three productions related to the New Georgian School LLC (change of place/area of implementation of primary, basic, secondary level programs). During the

presentation, the chairman of the expert group, Lia Kobesashvili, spoke about the circumstances that caused the institution to change the place/area of the general education programs. In particular, according to the lease

agreement, the New Georgian School Ltd. had the right to use "Kazbegis 47" LLC for a period of 6 years (including June 2028). Owned space (Tbilisi, Kazbegi St. N47, 3rd floor). Based on the agreement of June 30, 2023, the lease was terminated on August 1, 2023. Based on the current situation, New Georgian School Ltd. searched for a new premises, which is located in St. Tbilisi, Kuchishvili st. N6. A six-year contract was signed with the owner of the building "International Telcell, LLC (formerly International Telcell inc, a limited liability company duly organized and incorporated under the laws of the State of Delaware)". Based on the above, the school has made an application to change the general education programs/area. The chairman of the expert group talked about the recommendations given during the previous visit and noted that some of them lost their relevance due to the change of premises, while the school corrected the recommendations related to the rules of procedure, internal regulations and documentation of the school doctor. The school also brought the contract with the leading teacher into compliance with the requirements of the legislation.

The chairman of the expert group noted that in relation to the third standard, the school was more than compliant in B3.4 and 3.5 components, while all other components were evaluated in full compliance with the standard.

The expert added that the institution fully shared the experts' assessments and submitted a compliance plan along with an argumentative position. The school was given recommendations to provide within the time frame outlined in the compliance plan: With regard to component 3.4:

- agree on the emergency management plan with the relevant agency (September-November, 2023); to obtain a conclusion
- on compliance of buildings with fire safety requirements (August-November, 2023); to obtain a conclusion on the safety of operation of the
- building (August-November, 2023); ensure purchase of additional video surveillance cameras/system assembly
- (August-September, 2023); to ensure the search/employment of a suitable staff for the position of a doctor (August-November,
- 2023).

3.5 In relation to the component:

- to purchase and arrange a ramp (August-September, 2023); to
- arrange an adapted bathroom (August-September, 2023).

The member of the council, Shalva Mekravishvili, addressed the school with a question, why the circumstances required by the standard could not be taken into account when changing the place/area of the general education program. In this regard, the representative of the school explained that they had to change the premises in a short period of time, due to which the search for a new premises was associated with problems, and similar risks were taken into account in the renewed lease agreement. As soon as the lease agreement was signed, they began to implement the relevant activities to bring the new premises into full compliance with the requirements of the standard. The chairman of the expert group discussed with the council members the form and term of monitoring.

The representative of the school appealed to the Council to set September 18, 2023 as the date of entry into force of the decisions, since the school had planned and agreed with the Ministry of Education and Science of Georgia on September 25 as the starting date of studies, therefore, in order to start the educational process smoothly, it was important to implement the decisions from September 18, 2023. Council members unanimously agreed to the motion.

The chairman of the council put to the vote the issue of changing the place/area of implementation of the general educational program of the primary level of the new Georgian school.

The member of the council, Ekaterine Kvirikashvili, did not support the issue of changing the place/area of the implementation of the general educational program of the primary level of general education, since the school did not present a conclusion on the sustainability of the building and from the point of view of the safety of the students, it was not considered appropriate to carry out the educational process in the building.

The chairman of the council, Davit Malazonia, asked the representatives of the institutions if they had any complaints against the members of the council. The representatives of the institution confirmed that they had no objections to the members of the council. The chairman of the council, Davit Malazonia, appealed to the members of the council to confirm that they were familiar with the conclusions of the authorization expert groups and the argumentative position presented by the institution in relation to the draft conclusions. Council members confirmed that they were familiar with the case materials. The Chairman of the Board, David Malazonia, asked the stakeholder representative if he was familiar with the findings of the Authorization Expert Group. A representative confirmed that he was familiar with the findings. Accordingly, the Chairman of the Council requested the Secretary of the Council to attach the conclusions of the expert group to

the minutes as an integral part thereof.

The chairman of the expert group, Irma Khutsishvili, noted that until now the school was carrying out educational activities on the Kakheti highway and at the current stage was planning to implement general education programs at all three levels in the city of Tbilisi, near Lisi Lake, at Leo Kvatchadze 19 and st. in the cellar. The school was authorized in 2019 and had a limit of 500 students, and at the time of the visit there were 183 active students. Teaching in the school was conducted in the Georgian language. The chairperson of the expert group noted that with respect to the third standard, all components were assessed as fully compliant. It was also noted at the meeting that the school, together with the compliance plan, presented the emergency management plan, which was agreed with the relevant agency. Thus, the mentioned indicator was presented in the final conclusion as fully relevant. The chairman of the expert group, Irma

Khutsishvili, presented visual material to clearly present the infrastructure of the school. The chairman of the board directed the experts to present their conclusions about other productions related to the same school and then to vote. Council members agreed to this.

The chairman of the expert group, Lela Jash, presented the results of the evaluation regarding the addition of the general educational programs of elementary, basic and secondary level carried out in different municipalities of International Educational Schools LLC. Lela Jash spoke about the best practices of the school, including the implementation of intercultural principles, promotion of

professional development of employees and additional services provided to teachers (transportation, insurance). Also, regarding the permanence of working meetings. At the meeting of the school

On the positive side, the high share of non-formal education, innovative projects and the organization of the Olympics in the STEM direction were noted, the school also actively promoted the involvement of parents.

The expert noted that the school had about 30 students who were given the status of special education students due to the language barrier. The

expert explained that during the visit St. In Marneuli, the arrangement of the adapted bathroom was not completed, which was presented as a defect in the final draft, the school presented the relevant material along with the argumentative position, proving that the defect was eliminated. In the final conclusion, all components of the third standard were assessed as fully compliant. As part of the evaluation of the school curriculum standard,

the primary, basic and secondary level curricula were evaluated in accordance with the standard. Zviad Goguadze, a member of the council, addressed

the school with a question about what support mechanisms they had in connection with the implementation of the third generation national curriculum. The representative of the school, Manana Turkadze, explained that the school's employees were involved in online trainings from the first day, and the school also ensured the invitation of subject experts to organize trainings for teachers.

The representative of the school appealed to the council to make the decisions about the change of the area of general education programs and the addition of general education programs effective from September 18 of this year in order to start the educational process smoothly. The council unanimously supported the said motion.
